Sub.- Appointment of District Election Officer (CCP) for General Elections to Corporation of City of Panaji.

Whereas the General Elections to the Corporation of City of Panaji in the North Goa District of the State of Goa are scheduled to be held in March, 2016.

And whereas the State Election Commission is vested with the power of superintendence, direction and control of the preparation of the electoral rolls and the conduct of all elections to the Corporation of City of Panaji.

Now, therefore, in exercise of the powers vested in me under Article 243 ZA of the Constitution of India read with Section 11 of The City of Panaji Corporation Act, 2002, I, the undersigned, State Election Commissioner, Goa do hereby appoint the Collector and District Magistrate, North Goa District as District Election Officer (CCP) for the purpose of discharging the following duties in respect of General Elections to CCP to be held in March, 2016.

1. Subject to the superintendence, direction and control of the State Election Commission, the District Election Officer (CCP) shall

co-ordinate and supervise all work in the district or the area within his jurisdiction in connection with the conduct of the General Elections, 2016 to the Corporation of City of Panaji.

2. The District Election Officer (CCP) shall also perform such other functions as may be entrusted to him by the State Election Commission.

In exercise of the powers conferred upon the undersigned State Election Commissioner under Section 11 (2) of the City of Panaji Corporation Act, 2002, the powers and functions of overall supervision on the functioning of the Returning Officer/Assistant Returning Officer for General Elections to CCP are hereby delegated to the District Election Officer (CCP), subject to the overall control and superintendence of the State Election Commission.
