In exercise of the powers conferred on me vide Rule 5 of The Goa Panchayat and Zilla Panchayat (Election Procedure) Rules, 1996, I, *Dr. M. Modassir*, Commissioner of Goa State Election Commission, hereby notify that the Electoral Rolls of the Goa Legislative Assembly prepared under the provisions of The Representation of People Act, 1950 (Central Act 43 of 1951) with 1st January, 2012 as the qualifying date and for the time being in force as on 14th February, 2012 for such Constituencies of the Assembly or any part thereof as is included in the area within the jurisdiction of

the Village Panchayats shall be divided by the Mamlatdars of the Talukas of the State of Goa into different sections corresponding to the different wards of the Panchayats contemplated under sub-section (1) of Section 3 of The Goa Panchayat Raj Act, 1994 as per the Notifications to be issued by the Director of Panchayats and amended from time to time for the purpose of ensuing General elections to Village Panchayats under sub-section (3) of section 7 of The Goa Panchayat Raj Act, 1994.
