FOREWORD



The historic 73rd and 74th Constitutional Amendments in the year 1992 provided for not only the Constitutional status to all the Local Self Governments (LSGs) in the country but also an independent State Election Commission in each State for conducting elections to all LSGs regularly in a free, fair and transparent manner.

Pursuant to these Amendments, State Government enacted The Goa Panchayat Raj Act, 1994 to govern the local bodies at two levels-villages and district. The Goa Municipalities Act was enacted earlier in the year 1968 to govern the Municipalities in the state. A separate Legislation was brought in to govern the Municipal Corporation of the city of Panaji, called the Corporation of the City of Panaji Act, in the year 2002. The State Election Commission has been constituted under Article 243K and 243ZA of the Constitution of India, which is vested with the Superintendence, direction and control of the preparation of electoral rolls and the conduct of all elections to the Local bodies.

The boundaries of the wards are determined by the Government and the reservation of seats/wards in a local body is also done by the Government in accordance with Law. The geographical area of Goa has been divided into 2 Zilla Panchayats, 191 Village Panchayats, 13 Municipal Councils and 1 Municipal Corporation.

The Commission had earlier published a report on the General Elections to 186 Village Panchayats out of 191 total Village Panchayats that were held in June- July, 2017. Commission thereafter in the year 2017 successfully conducted General Elections to three Village Panchayats, Bye Elections to four Zilla Panchayat Constituencies and six wards of six Village Panchayats.

Subsequently, in the year 2018 General Elections to two Municipal Councils namely Ponda Municipal Council and Sanquelim Municipal Council were held in the month of April and May respectively. In addition, Bye election to 1 Municipal ward and 9 wards of 9 different Panchayats were conducted in the same year.

The Commission appointed General Observers and Expenditure Observers as its representatives in the field to oversee conduct of election process in general and to monitor implementation of the Election Code of Conduct in particular. It is worth pointing out that size of the electorate in Village Panchayat wards is often not more than 300 and the voting percentage also sometimes goes upto 98 percent but the interesting thing noticed is that

sometimes the winner is declared elected by holding draw of lots in presence of the

Returning Officer which has been so provided under the Election Rules of the Local bodies.

The Commission acknowledges the support extended by the State Government

wherever that was required and it fully appreciates and recognises the contributions made

by the Election machinery comprising of the officers and staff of the Revenue Department

under the control of the respective District Collector and that of the Police Department under

the control of the S.P. concerned who extended their full support to the Commission to

ensure conduct of all above Elections in a free, fair and peaceful manner.

The Commission has made an effort to compile all above election related

information/documents for the purpose of future reference and record and hopes that it will

be found useful by its users.

Srivastava, Commissioner, Goa State Election Commission, Panaji hereby notify that the Electoral Rolls of the Goa Legislative Assembly prepared under the provisions of Representation of People Act, 1950 on 1st January, 2018 as the qualifying date and for the time being in force as on10th January, 2018 for such constituency of the Assembly or any part thereof as in Ponda Municipal area shall be divided into different sections corresponding to different wards of Ponda Municipal Councils fixed by the Director of Municipal Administration under Section 10 of the Goa Municipalities Act, 1968 as per the delimitation going to be notified by the Government.

In exercise of the powers conferred upon this Commission under Article 243ZA of the Constitution of India read with Section 10A of the Goa Municipalities Act, 1968, I, R. K. Srivastava, State Election Commissioner, Goa hereby direct as under:-

Whereas, as per sub-rule (2A) of Rule 12 of the Goa Municipalities (Election) Rules, 1969, it is incumbent upon the candidates to file an affidavit in the prescribed Form XXIII alongwith the nomination;

And whereas, if any candidate fails to file the said affidavit alongwith the nomination paper, the Returning Officer should bring this defect to the notice of the candidate/proposer presenting the nomination form.

It is further directed that no column of the affidavit should be left blank or filled by just tick/dash marking. If the information asked for in a column is Nil or not applicable to the particular candidate, then he should write "Nil" or "Not applicable" in that column. A standard format for this purpose is given at Annexure "A".

A copy of blank Form XXIII should be issued to the candidate or his proposer immediately on presentation of the nomination paper and candidate should be asked to file duly sworn affidavit along with the nomination papers.

In case there is a request from any person to seek copies of the affidavit filed by a candidate/candidates, they may be given a copy on payment of copying charges at the rate of Rs. 2/- per page.

If any candidate fails to file prescribed affidavit till the last date and time of nominations, the Returning Officer shall reject his candidature during Scrutiny for non-compliance of Rule 2A.

The Returning Officer shall not go into the aspect of verification/truthfulness of the contents of the affidavit sworn by the candidate during the Scrutiny of the nominations or during the election process.





Vote casting percentage of Male & Female voters







Vote casting percentage of Male & Female voters







Two hourly Voting trend of Male & Female Voters


General Election to Ponda Municipal Council



Two hourly Voting trend of Male & Female Voters General Election to Sakhali Municipal Council




Average Voting Percentage in General elections to urban and Rural local bodies





Average Voting Percentage in Bye elections to urban and Rural local bodies




