## FOREWORD



The State Election Commission has been constituted under Article 243K and 243ZA of the Constitution of India. The Commission is vested with the Superintendence, direction and control of the preparation of electoral rolls and the conduct of all elections to the Local bodies. The powers and responsibilities vested in the State Election Commission under Articles 243 K and 243 ZA are identical with that of the Election Commission of India under Article 324(1) as has been also confirmed by the Hon'ble Supreme Court of India in the case of Kishan Singh Tomar Vs. Municipal Corporation of the City of Ahmedabad.

The Local bodies were given a constitutional status on par with the Union and States by way of **73<sup>rd</sup> & 74<sup>th</sup>** Constitutional Amendments brought in the year 1993. It is interesting to note that Articles 243 E (3) and 243 U (3) expressly mandate the conduct of elections to local bodies before completion of the ongoing tenure while there is no such provision concerning the Lok Sabha under Article 83. . In view of the aforesaid constitutional provisions, the responsibility to hold elections to local bodies in time rests with the State Election Commission. The vacancies occasionally arising in the local bodies also need to be filled up by the Commission by conducting bye elections within a period of six months from the date of the said seat falling vacant.

The geographical area of the state of Goa has been divided into 2 Zilla Panchayats, 191 Village Panchayats, 13 Municipal Councils and 1 Municipal Corporation. The boundaries of the wards are determined by the Government and the reservation of seats/wards in a local body is also done by the Government in accordance with Law.

It may be recalled that General Elections to 186 Village Panchayats were held during May-June 2017. Thereafter, 3 Village Panchayats of Alorna, Casavarnem, and Chandel-Hasapur had their General Election in December 2017. Then in the year 2018, General Elections to Ponda

Municipal Council and Sanquelim Municipal Council were held in the months of April and May 2018 respectively. Apart from above, Bye elections to one Municipal ward and 9 wards of different Panchayats were also held in that year on different dates. Reports of above Elections have already been published by the Commission earlier.

It gives me immense pleasure in presenting this Report on the Elections conducted by the State Election Commission of Goa for the Year 2019. During the year, general elections to the two remaining village panchayats namely, Taleigao and Harvalem were conducted in the months of April and August respectively. In addition, bye elections to 2 Zilla Panchayat constituencies, 5 wards of different Panchayats and 1 Municipal ward were also conducted at different points of time.

The Commission appointed General Observers and Expenditure Observers as its representatives in field to oversee the conduct of election process in general and also to monitor implementation of the Model Code of Conduct in particular. The Election machinery comprising of the officers and staff of Revenue Department under the control of the respective Collector and that of the Police Department under the control of the S.P. concerned extended their full support to the Commission to ensure conduct of all above Elections in a free, fair and peaceful manner. The Commission acknowledges and values the support extended to it by the Govt machinery in the smooth conduct of Elections.

The Commission hopes that this compilation of all election related information would be found quite useful by all stakeholders concerned with elections to the Local bodies.

The Observer shall look into public grievance regarding violations of Code of Conduct, Malpractices by the candidates and proper functioning of RO/ARO.

The date of Poll will be on 28th April, 2019 and the hours of Poll will be from 8.00 a.m. to 5.00 p.m. The Counting of Votes shall be done on 29/04/2019 from 8.00 a.m. till the Counting is over. The above Officer shall take charge of his duties on 15<sup>th</sup> April, 2019. He shall submit report on 29th April, 2019 latest by 5.00 p.m. through fax or through special messenger.

The duties and responsibilities attached to the Observer appointed by the State Election Commission shall be as shown below:-

- a) To watch the conduct of election and the counting of votes and to guide the Returning Officer in conducting training classes for polling personnel and counting rehearsals.
- b) In case of irregularities noticed by the Observer, Returning Officer may be directed to initiate action as per provisions of Law and Model Code of Conduct in force under intimation to the State Election Commission so as to conduct election in free & fair manner. For this purpose the Observer is permitted to use Telephone/Fax facilities available in the Office of the Returning Officer. All such cases should be reported by the Observer to the State Election Commission and also to the Returning Officer separately.
- c) Copies of the following documents may be collected at the earliest:
  - i. Authority letter to enter the polling stations and place of counting.
  - ii. Car pass for Observer.
  - iii. List of Polling Stations.
- d) A copy of passport size photograph may kindly be made available to the Commission for the purpose of issuing a badge to the Observer.
- e) The Observer will have to submit to the State Election Commission immediately after the last day of Counting of Votes, a brief note containing his observations at the time of election and counting alongwith his suggestion, if any.

- f) The Observer shall use his own department official vehicle.
- g) The Returning Officer shall provide adequate security and support services suchas fuel, stationery etc. to the Observer.
- h) The HOD under whom the Observer is working shall provide him a vehicle and driver with adequate petrol from time to time and relieve him immediately to function as Observer of this Commission in addition to his own duties.

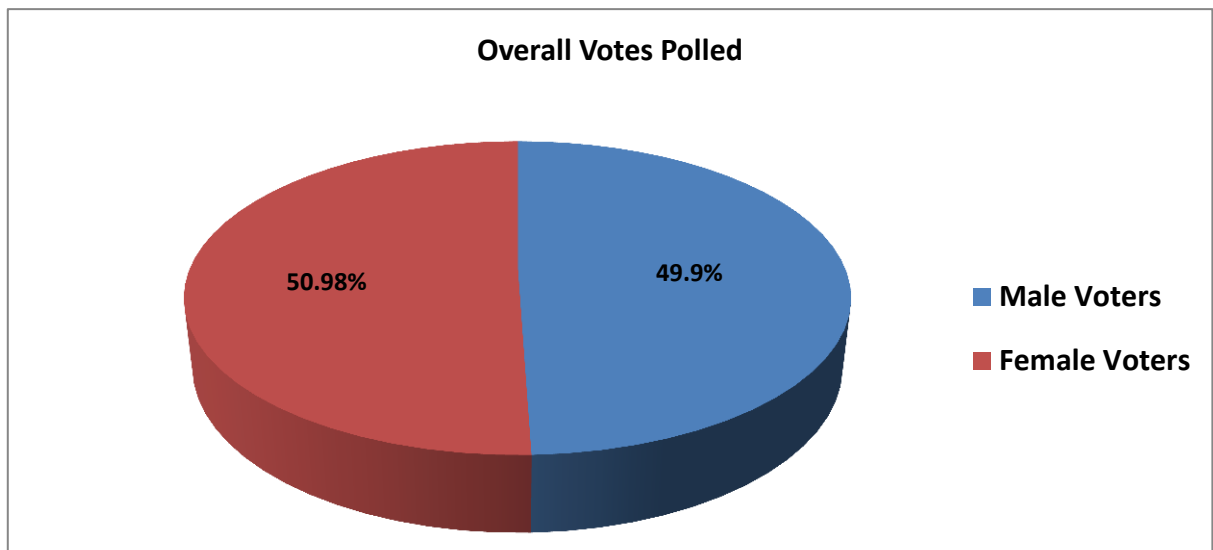
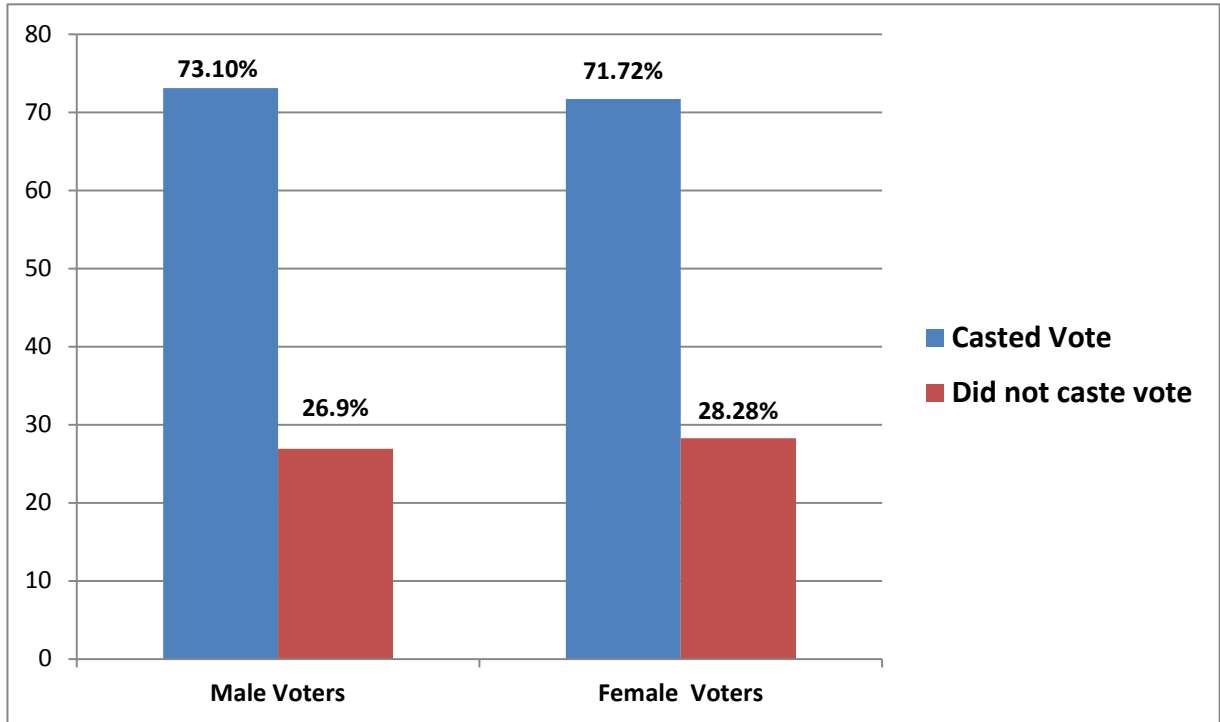

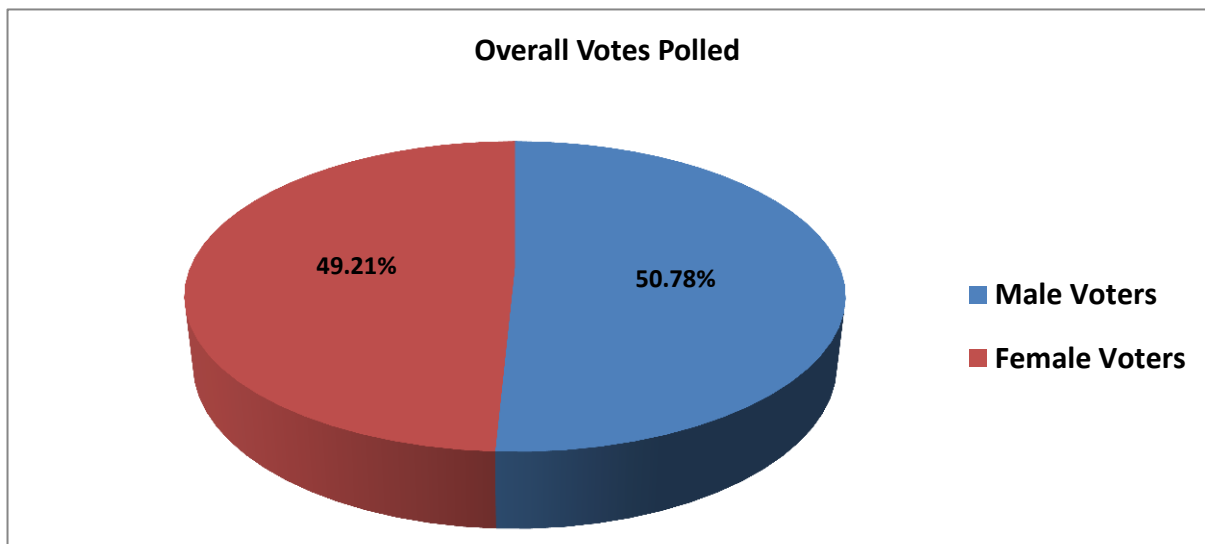
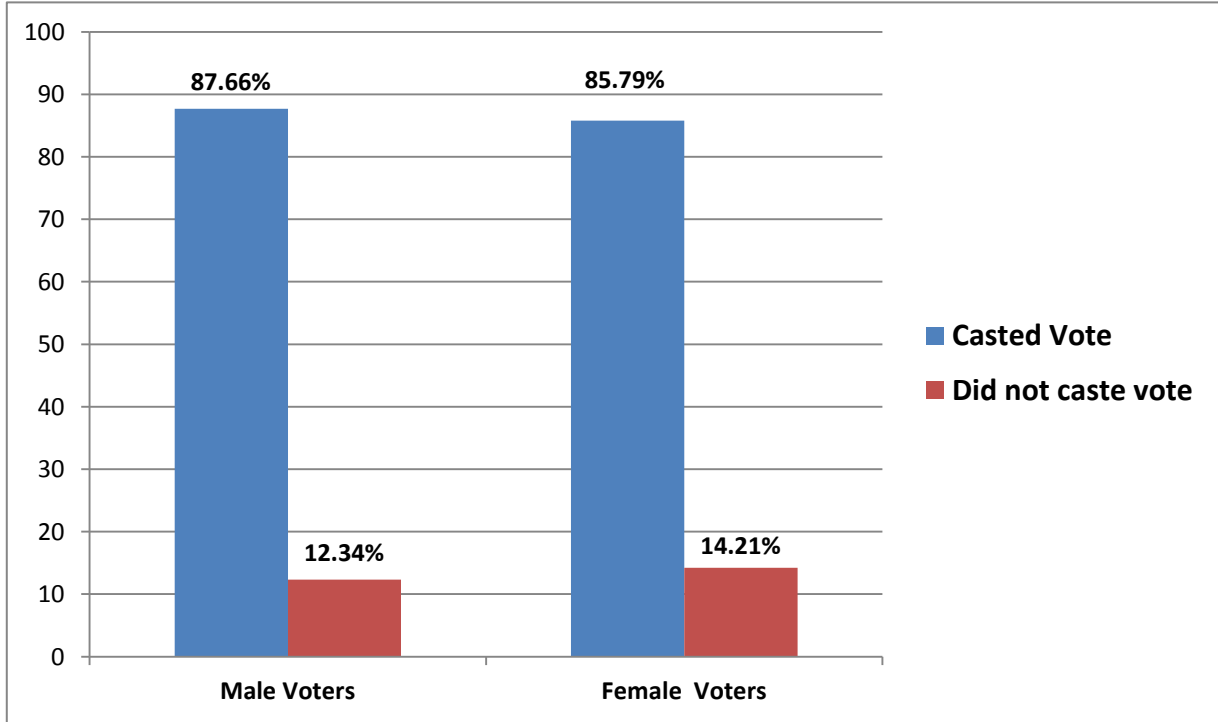
## General Election to Rural Local Bodies

### Vote casting percentage of Male & Female voters

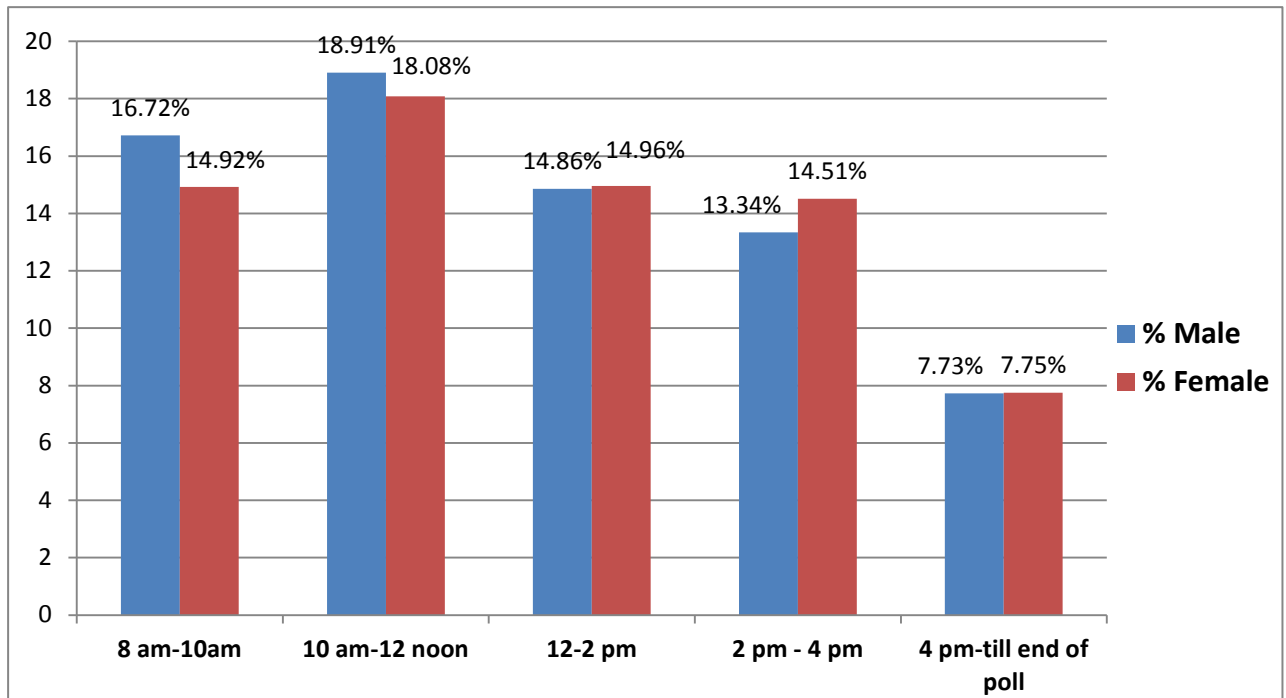
