FOREWORD



Chokha Ram Garg, IAS Commissioner

It gives me immense pleasure in presenting this report on the Elections conducted by the Goa State Election Commission in the year 2020. During the year, Fifth General Election to the two Zilla Panchayats in the State namely North Goa Zilla Panchayat and South Goa Zilla Panchayat was held on 12th December, 2020.

One bye election to one ward of Village Panchayat Telaulim in Salcete Talukawas also held in the month of January, 2020.

The General Election to the 25 Zilla Panchayat constituencies each of North Goa and South Goa Zilla Panchayat was notified by the Government to beheld on 15th March, 2020 and later the date was changed to 22nd March, 2020. As per the provisions of the section 13 of the Goa Panchayat Raj Act, 1994; the Electoral Rolls of the Legislative Assembly of the State for the time being in force are to be used for holding election to the Zilla Panchayats. Accordingly, the Electoral Roll notified by the Office of the Chief Electoral Officer, prepared under the provisions of Representation of People Act, 1950 (Central Act 43 of 1951) for the time being in force as on 1st January, 2020 was used for holding the polls. The Commission acknowledges the support extended by the Office of the Chief Electoral Officer in this regard. The boundaries of the ZP Constituencies and the reservation of seats / ZP constituencies was done by the Government in accordance with Law.

Total 305 candidates filed 345 nominations for 50 ZP Constituencies. After scrutiny, valid nominations of 236 candidates were accepted and nominations of 69 candidates were rejected. 32 candidates withdrew their candidature on the day designated for withdrawal of nomination. A candidate Sponsored by Bhartiya

Janata Party from ZP Constituency 24-Sancoale was elected unopposed. Thus 104 candidates for North Goa Zilla Panchayat and 96 candidates for South Goa Zilla Panchayat were in fray. On 20th March, 2020, Government vide its notification postponed the elections to Zilla Panchayats scheduled on 22nd March, 2020 to prevent the spread of Covid-19. It was also clarified in the notification that the entire election process up to the stage of campaigning will be held valid and only the date of the polling has been postponed.

Unfortunately due to the death of a candidate sponsored by Indian National Congress election to the ZP Constituency 16-Navelim was countermanded.

The commission after reviewing the situation of Covid-19 in the State and analysing the guidelines and SOPs issued by Election Commission of India (ECI) for holding elections during Covid times, decided to hold polls for 48 Zilla Panchayat Constituencies on 12th December, 2020. The Commission issued its own set of guidelines/SOP for holding the ZP polls in view of Covid-19 pandemic.

As the Goa Panchayat Raj and Zilla Panchayat (Election Procedure) Rules, 1996 provide for holding the election through Ballot paper and accordingly polls were held using ballot papers. There were 791814 voters in 48 Zilla Panchayat constituencies, out of which 385222 were male and 406592 were female. Total 1187 polling booths were setup for holding the polls, out of which 641 polling booths were in North Goa and 546 were in South Goa. 6 polling stations in North Goa and 4 in South Goa were declared as sensitive polling stations. Covid-19 Positive patients were allowed to cast their vote in last hour of the poll i.e from 4.00 pm to 5.00 pm. Total 31, Covid-19 positive voters exercised their franchise by following the precautionary guidelines for Covid-19. PPE kits were provided to these voters before entering the polling station. Inspite of Covid-19 pandemic, the final polling percentage was 56.86 %.

The entire Zilla Panchayat election process was monitored on real time basis by the Commission through Election Management System (EMS), which is a real time monitoring web based software. EMS enabled real time data recording for

pre-poll, Poll and Post-Poll activities including real time information,

communication and its dissemination.

The Commission appointed General Observers and Expenditure Observers as

its representatives in field to oversee the conduct of election process in general and

also to monitor implementation of the Model Code of Conduct in particular. The

Election machinery comprising of the officers and staff of Revenue Department

under the control of the respective Collector and that of the Police Department

under the control of the S.P. concerned extended their full support to the

Commission to ensure conduct of all above Elections in a free, fair and peaceful

manner.

Efforts have been made to present the complete details right from the

notification of election programme up to the counting of votes and declaration of

results. The Commission hopes that this compilation of all election related

information would be quite useful to all stakeholders concerned with elections to

the Local bodies.

I acknowledge the sincere contribution made by the Collectors/DEOs,

Returning Officers, Asst. Returning Officers, General Observers, Expenditure

Observers, OSDs to the Commission and all other Government officers and

officials including the officers and officials of the Goa Police, Government

Printing Press and other officers and staff drawn by the Commission to assist it in

the conduct of the whole election process in a smooth, peaceful and flawless

manner and take this opportunity to thank the one and all.

SOP/guidelines issued by State Election Commission for holding Zilla Panchayat Elections in view of the Covid-19 pandemic.

I. General instructions about Preventive measures to be taken at the Polling stations for the Zilla Panchayat Elections 2020.

- i. All Voters are to be thermally screened for temperature at the entry of the polling station.
- ii. Norms of social distancing by marking circles at 2 metre distance for the voters to stand in a queue outside the polling station and, allowing entry of limited number of voters in the marked circles near the entrance of the polling station shall be strictly followed.
- iii. The provision of hand sanitisers at the entrance of the polling stations shall have to be made without fail.
- iv. The place used for setting up the polling station and all the materials/items used shall be properly sanitized before setting it up. Proper cleaning and frequent sanitization of the workplace, particularly of the frequently touched surfaces like tables, ballot boxes, cross mark, metal strip, etc must be ensured by the polling staff on duty.
- v. Polling parties shall be provided with hand gloves.
- vi. Use of face covers/ masks is mandatory for all.

- vii. If the temperature is above prescribed norms, the Voter shall be asked to sit in the shed for 10 minutes and the second reading will be taken. If the 2nd reading is still higher than the prescribed norms, then the Voter will be asked to come for poll at the last hour of Poll i.e. 4.00 pm to 5.00 pm.
- viii. Covid-19 positive persons will be allowed to cast their vote during the last hour of the polling day i.e. between 4.00 p.m. to 5.00 p.m.
 - ix. The BLOs shall be instructed to identify the Covid Positive person in each Polling Station.
 - x. The required number of PPE kits and hand gloves based on the number of Covid positive person shall be provided by the Returning Officer to the BLOs which shall be used by the Covid positive persons when they come to the Polling Station for voting.
 - xi. The Covid positive person shall display their identity proof to the Polling Staff.
- xii. Frequent hand washing with soap /alcohol-based hand sanitizers will be used.
- xiii. Hygiene related etiquettes to be strictly followed by all. This involves strict practice of covering one's mouth and nose while coughing/sneezing with a tissue/ handkerchief/flexed elbow and while disposing off used tissues properly in dust bins.
- xiv. Spitting shall be strictly prohibited.
- xv. Drivers deployed on election duties shall follow required do's and don't's related to COVID-19. A proper sanitization/disinfection of vehicle steering, door handles, keys, etc. should be carried out.

II. Specific preventive measures required at the Distribution/Collection and Counting Centres.

- i. The provision of hand sanitiser at the entrance will have to be made and only the asymptomatic staff/visitors/candidates and their agents shall be allowed after thermal screening at the entrance of the Distribution/Receiving/Counting Centres.
- ii. The place used for setting up the Distribution/Receiving/Counting Centres and all the materials/items used shall be properly sanitized.
- iii. The face cover/mask has to be worn at all times by all inside the distribution, collection and counting centres.
- iv. Seating arrangement for polling personnel and counting staff at the distribution, collection and counting centres is to be made in such a way that adequate social distancing is maintained.
- v. Large gatherings outside the distribution centre, collection centre, and counting centres and inside the counting halls will not be allowed.
- vi. IEC/awarness material on preventive measures about COVID-19 to be displayed prominently at suitable places.
- vii. A Gazetted officer may be designated for dealing with the election staff who may develop Covid-19 symptoms during election duty to coordinate with the Health authorities and the RO. The following measures will be taken in such circumstances:
 - a) When one or more staff members on poll duty is found to be suffering from symptoms suggestive of COVID-19 either in the office on the election duty, the said person/s should be placed in a separate room or area where he is isolated from others at the workplace.
 - b) The nearest medical facility (hospital/clinic) may be immediately informed and the state or district helpline should be immediately called.

c) The advice of the designated public health authority may be sought for carrying out a risk assessment and for making further advice regarding management of the said case, his/her contacts and the need for carrying out disinfection of the said premises as per Government instructions, if any.




