

**ORDER**

**WHEREAS,** the General Elections to the 5 Municipal Councils viz Mapusa, Mormugao, Margao, Quepem and Sanguem, in the State of Goa are declared vide notification No. 4/21/GMCNSE/SEC-2021/881 dated: 30/03/2021.

**AND WHEREAS,** under Article 243ZA of the Constitution of India, read with Section 10A of the Goa Municipalities Act, 1968 the State Election Commission is vested with the powers of superintendence, direction and control for the conduct of elections to the Municipal Councils.

**NOW THEREFORE,** the State Election Commission in exercise of the powers conferred upon it do hereby notifies that the Model Code of Conduct shall be applicable from 30/03/2021 till midnight of 26/04/2021 or till the Election process is completed. The Code of Conduct shall be applicable to all the areas under the jurisdiction of above referred Municipal Councils.
