
The Programme of Election is as Under:

1	Last date and time for receiving nominations papers.	Thursday, 8 th April, 2021 From 10.00 hrs. to 13.00 hrs.
2	Date and time for scrutiny of nomination papers.	Friday, 9 th April, 2021 From 10.00 hrs. till the scrutiny is over.
3	Date and time of withdrawal of nomination papers.	Saturday, 10 th April, 2021 From 10.00 hrs. to 14.00 hrs.
4	Date and time of poll.	Friday, 23 rd April, 2021 From 08.00 hrs. to 17.00 hrs.
5	Date and time of Counting.	Monday, 26 th April, 2021 From 08.00 hrs. till the Counting is completed

(iv) A voter in a constituency is entitled to cast only one vote.

(v) Form of nomination paper will be available in the office of the Returning Officer during office hours.

(vi) In case of general seat, a sum of Rs. 100/- (Rs. One hundred only) and in case of seat reserved for a woman or a person belonging to Scheduled Castes/ Scheduled Tribes or Backward Class, a sum of Rs. 50/- (Rs. Fifty only) is required to be deposited with the Returning Officer on or before the date fixed for receiving the nomination papers.
