ORDER

In exercise of the powers conferred in me under Sub Section (3) of Section 7 of the Goa Panchayat Raj Act, 1994 (Goa Act 14 of 1994), I, W V Ramanamurthy, IAS (Retd.), Commissioner Goa State Election Commission, Panaji-Goa hereby initiate the process of dividing each Panchayat area into wards, going to polls for General Elections 2022. To assist me in the above process the Officers mentioned below are appointed as the Electoral Registration Officers (ERO) and Asst. Electoral Registration Officers (AERO):-



The officers appointed vide this order are required to perform following duties:

1. The EROs/AEROs shall utilize the Electoral Roll of the Goa Legislative Assembly prepared under the provisions of the Representation of Peoples Act, 1950 (Central Act 43 of 1951) for the time being in force as on 1st January, 2021 (Published on 15th January 2021) to form Village Panchayat wards, considering the Part and Sections of the said Electoral Roll and send the Proposals to this Commission at first instance latest by 15th December, 2021.
2. The EROs/AEROs while forming Village Panchayat wards shall give due consideration to geographical contiguity and natural boundaries.
3. The wards may be proposed in consonance to Section 7 of the Goa Panchayat Raj Act, 1994 (Goa Act 14 of 1994).
4. The EROs/AEROs shall prepare ward wise Village Panchayat map and submit the same along with the final proposal.
5. Further the final published Electoral Roll of the Goa Legislative Assembly with qualifying date as 1st January, 2022 shall be utilized to assign voters to the Panchayat wards and reformation of the Panchayat wards if required. The final proposals may be submitted to this Commission thereafter
