Read: Order No. 3/30/Reservation/GEVP-186/2022-23/SEC/3423 Dated 13-07-2022.

Subject:- Reservation of seats in Village Panchayats for General Elections 2022.

In partial modification of Order referred above which is published in Extraordinary Official Gazette Series II No. 13 dated 01-07-2022, this Order is hereby issued.

Whereas, the Goa State Election Commission in exercise of the powers conferred upon notified the reservation of seats for Scheduled Castes (SC), Scheduled Tribes (ST), Other Backward Classes (OBCs) and Women for 185 Village Panchayats for ensuing General Elections 2022 vide Notification No. 3/30/Reservation/GEVP-186/2022-23/SEC/3424 dated 13-07-2022.

And whereas, The Government vide letter dated 15-7-2022 submitted the applications with regards to reservation of Village Panchayat Pale-Kotambi, Cudnem, and Navelim in Bicholim Taluka, Village Panchayat Collem in Dharbandora Taluka, Village Panchayat Pilerna Marra, Saligao and Socorro in Bardez Taluka, Village Panchayat Veling Priol Cuncoliem in Ponda Taluka and Village Panchayat Nagargao in Sattari Taluka to revisit the reservation of these Village Panchayats.

And whereas, Committee constituted to propose the reservation of seats examined the said applications and suggested modifications and submitted the report to the Commission.

Now Therefore, State Election Commission in exercise of the powers conferred upon it do hereby issue the corrigendum to the Notification No. 3/30/Reservation/GEVP-186/2022-23/SEC/3424 dated 13-7-2022 for General Elections to Village Panchayats 2022 as annexed to this order.

Whereas, the General Election to 186 Village Panchayat in the State of Goa are declared vide Notice of Election and Public Notice in Form I dated 30-06-2022 published in Official Gazette Series II No.13.

And whereas, under Article 243K of the Constitution of India, read with Section 237 (1) of the Goa Panchayat Raj Act, 1994 the State Election Commission is vested with the power of Superintendence, direction and control of the preparation of the electoral rolls for, and Conduct of, all elections to the Panchayat or Zilla Panchayat.

Now Therefore, the State Election Commission in exercise of the powers conferred upon it do hereby notifies that the Model Code of Conduct

shall be applicable from **16-07-2022 (Saturday) till completion of election process**. The Code of Conduct shall be applicable in all the Village Panchayat areas excluding those mentioned below:-

- A) Village Panchayats:-
- 1) Alorana, Casarvarnem & Chandel Hassapur in Pernem Taluka.
  - 2) Harvalem in Bicholim Taluka.
  - 3) Taleigao in Tiswadi Taluka.
- B) All Municipal areas in Goa.
- C) Corporation of the City of Panaji.
