One Hundred only) and in case of seat reserved for a woman or a person belonging to Scheduled Castes/Scheduled Tribes or Backward Class, a sum of Rs. 50/-(Rs. Fifty only) is required to be deposited with the Returning Officer on or before the date fixed for receiving the nomination papers.
