Now, therefore, in exercise of the powers vested under Article 243K of the Constitution of India and also under Section 237 of the The Goa Panchayat Raj Act, 1994 read with Rule 34 of the Goa Panchayat and Zilla Panchayat (Election Procedure) Rules, 1996 it is hereby directed that the indelible ink mark shall be put on **Left forefinger** of every voter of Ward No. I of Village Panchayat Tivim, Ward No. VII of Village Panchayat Assonora, and Ward No. I of Village Panchayat Chicalim at the polling Station before issue of ballot paper.
