## ORDER

AND WHEREAS, under Article 243K of the Constitution of India, read with Section 237 (1) of the Goa Panchayat Raj Act, 1994 the State Election Commission is vested with the power of Superintendence, direction and control of the preparation of the electoral rolls for , and Conduct of, all elections to the Panchayat or Zilla Panchayat.

NOW THEREFORE, the State Election Commission in exercise of the powers conferred upon it do hereby notify that the Model Code of Conduct shall be applicable from 29/11/2025 (Saturday) till completion of election process. The Code of Conduct shall be applicable in all the areas of North Goa Zilla Panchayat and South Goa Zilla Panchayat excluding those mentioned below:-

- A) All Municipal areas in Goa.
- B) Corporation of the City of Panaji
