

3	Date and time of withdrawal of nomination papers.	Thursday, 11 <sup>th</sup> December, 2025 From 10.00 hrs. to 14.00 hrs.
4	Date and time of poll.	Saturday, 20 <sup>th</sup> December, 2025 From 08.00 hrs. to 17.00 hrs.
5	Date and time of Counting.	Monday, 22 <sup>nd</sup> December, 2025 From 08.00 hrs. till the Counting is completed

- (i) A voter in a constituency is entitled to cast only one vote.
- (ii) Form of nomination paper will be available in the office of the Returning Officer during office hours.

- (iii) In case of general seat, a sum of Rs. 500/- (Rs. Five Hundred only) and in case of seat reserved for a woman or a person belonging to Scheduled Castes/ Scheduled Tribes or Backward Class, a sum of Rs. 300/- (Rs. Three Hundred only) is required to be deposited with the Returning Officer on or before the date fixed for receiving the nomination papers.
